Formal Complaint of Frankie Baker against Rocky Mountain Power	<u>DOCKET NO. 19-035-26</u> <u>ORDER CANCELING HEARING</u>

ISSUED: June 19, 2019

On June 3, 2019, Frankie Baker (“Complainant”) filed a formal complaint (“Complaint”) against Rocky Mountain Power (RMP). On June 18, 2019, RMP filed a Motion to Dismiss (“Motion”) the Complaint with the Public Service Commission (PSC), explaining it has entered into a payment plan with the Complainant for the unpaid balance.

In light of the Motion, the PSC cancels the expedited hearing set for June 19, 2019. However, because the Motion does not represent the Complainant joins the Motion or otherwise consents to the dismissal, the PSC will allow the ordinary time for Complainant to file a response and, to the extent necessary, RMP to file a reply. Accordingly, Complainant may file a response to the Motion on or before **Wednesday, July 3, 2019**, and RMP may file a reply within 10 days after service of such response. If no response is filed, the PSC will deem the Motion unopposed. The PSC understands, given the Motion’s representation concerning the parties’ agreement to enter a payment plan, that RMP has no immediate intention of terminating Complainant’s service. Because the expedited hearing has been canceled and to protect Complainant’s rights under tariff and the Utah Administrative Code, RMP shall not terminate Complainant’s service during the pendency of the Motion without seeking and obtaining leave from the PSC.
