Rocky Mountain Power's Proposed Tariff Revisions to Electric Service
Regulation No. 4, Supply and Use of Service
Reply Comments

On September 25, 2019, PacifiCorp d.b.a Rocky Mountain Power ("Company") filed a proposed revised tariff page associated with Electric Service Regulation No. 4 (Supply and Use of Service). The Public Service Commission of Utah ("Commission") issued a Notice of Filing and Comment Period on September 26, 2019 ("Notice") that set a deadline for comments from interested parties by October 10, 2019 and reply comments on October 17, 2019. In accordance with the Notice, the Division of Public Utilities ("Division") filed comments on the Company's proposed revised tariff page stating that the requested modification is potentially necessary and in the public interest, but the Division did not fully understand the mechanics of the billing process and therefore requested that the Commission suspend Electric Service Regulation No. 4 to allow time for interested parties to gain understanding of the billing process.

The Company appreciates the Division's review of the Company's proposal. To address the Division's concerns, the Company and the Division have scheduled a meeting on October 28, 2019, to discuss the billing process. The Company recommends the Commission establish another comment period to provide the Division an opportunity to update its recommendation to the Commission once the meeting regarding the billing process has occurred. The Company and Division conferred and the Division indicated it supports the following schedule for a subsequent comment period:

- Interested party comments on or before Wednesday, November 13, 2019
- Reply comments on or before Wednesday, November 20, 2019

The Company respectfully requests the Commission suspend Electric Service Regulation No. 4 as recommended by the Division and issue a Notice of Comment Period with the deadlines listed above.


