ISSUED: October 22, 2019

On September 25, 2019, Rocky Mountain Power (RMP) filed proposed revisions to Electric Service Regulation No. 4 (“Tariff Revisions”), with an effective date of January 1, 2020. On September 26, 2019, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period, establishing comment and reply deadlines of October 10 and October 17, 2019, respectively. On October 10, 2019, the Division of Public Utilities (DPU) filed comments recommending the PSC suspend the Tariff Revisions “to give interested parties the necessary time to understand the billing process for small usage device customers.” On October 17, 2019, RMP filed reply comments stating it intends to meet with the DPU on October 28, 2019 to address the DPU’s concerns. RMP also requested the PSC suspend the Tariff Revisions and establish an additional comment period to provide the DPU an opportunity to update its recommendation after their meeting.

Accordingly, the PSC gives notice any interested party may submit comments on the Tariff Revisions on or before **Wednesday, November 13, 2019**, and may submit reply comments on or before **Wednesday, November 20, 2019**.
