On April 20, 2020, the Public Service Commission (PSC) issued a Report and Order in Docket No. 18-035-36 (“Depreciation Docket”) stating that the PSC will “establish Phase II to [the depreciation] proceeding and will establish a scheduling conference to occur concurrent with the scheduling conference in [Rocky Mountain Power’s (RMP) 2020 General Rate Case (GRC)].”<sup>1</sup> On May 8, 2020, RMP filed an application with the PSC in Docket No. 20-035-04 to increase its retail electric utility service rates and make tariff modifications (“2020 GRC Docket”). On May 14, 2020, the PSC issued a Notice of Filing and Telephonic Scheduling Conference in the 2020 GRC Docket.

The purpose of this amended notice is to confirm that the scheduling conference in the Depreciation Docket will take place concurrently with the previously noticed 2020 GRC scheduling conference.
