AMENDED SCHEDULING ORDER AND
NOTICE OF ELECTRONIC HEARING

ISSUED: November 12, 2020

On November 6, 2020, we issued a notice, and requested any objection to be filed by November 9, 2020, regarding a proposal for legal briefing and closing arguments in this docket. The Office of Consumer Services filed an opposition and proposal. We find that alternate proposal to be reasonable and we adopt it. Accordingly, we will allow, but not require, legal briefs not exceeding eight pages for each phase of this docket (i.e., cost of capital, revenue requirement, cost of service) in which the party presented testimony. These briefs may be filed on or before **Monday, November 30, 2020**, and should clearly indicate the phase of this docket the brief addresses. We will hear closing statements on **Friday, December 4, 2020 at 9:00 a.m. MST**, allowing parties up to 20 minutes for each phase of this docket in which the party presented testimony. Questions from the PSC will follow each closing statement. The PSC has made arrangements to pay for an expedited transcript of all hearings in this docket, but we cannot guarantee that all transcripts will be available in advance of either of these two dates.

Pursuant to Utah Code Ann. § 52-4-207, on this November 12, 2020, the chair of the PSC makes this written determination that, due to the COVID-19 pandemic and the continued risks of transmission in Utah, the hearing scheduled for **Friday, December 4, 2020 at 9:00 a.m. MST**, will be conducted as an electronic meeting without an anchor location. An anchor location would provide a substantial risk to the health and safety of those who may be present at the anchor

location. **The hearing will be conducted via Google Meet using the same connection information as the evidentiary hearings in this docket.** All parties must have their witnesses in attendance and prepared to provide their closing statements. The PSC will also stream the hearing through the PSC YouTube channel, which is available by link from the PSC website. Any interested person may view and listen to the hearing through that means without a need to connect to the video conference. The YouTube stream of the hearing will be available live, and will also be archived and available after the hearing is concluded.

The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating. Participants also may find it useful to have headphones or earbuds available in the event of feedback.

In the event of unresolvable technological problems related to the hearing's video conferencing, the PSC will have a separate conference telephone number available to continue the hearing by audio only.

In accordance with the Americans with Disabilities Act, individuals needing special accommodations (including auxiliary communicative aids and services) during the hearing should notify the PSC at 160 East 300 South, Salt Lake City, Utah 84111, (801) 530-6716, at least three working days prior to the hearing.
