Re: Dixie Power's Proposed Tariff Revisions, Docket Nos. 21-066-T02 and 21-066-T03

Dear Mr. Laub:

The Public Service Commission (PSC) reviewed Dixie Power's (Dixie) April 14, 2021 filing of new optional rate tariff schedules for interruptible irrigation pumping service, large commercial time of use service, and industrial service applicable to customers in Dixie's Flowell service area ("Tariff Schedules"). Dixie's Board of Directors approved the Tariff Schedules on January 6, 2021 and April 7, 2021 with an effective date of May 1, 2021. Dixie held a public meeting on April 13, 2021 soliciting members' comments on the proposed Tariff Schedules. The PSC also reviewed comments filed April 28, 2021 by the Division of Public Utilities (DPU) in response to the PSC's action request.

DPU commented that Dixie complied with Utah Code Ann. § 54-7-12(7) but did not provide the PSC notice of the Tariff Schedules 30 days before their effective date in compliance with Utah Code Ann. § 54-3-3. DPU further commented that Dixie timely notified its members of the new Tariff Schedules and that no significant or material harm would result from Dixie's failure to provide the PSC with the required 30-day notice. DPU recommends the PSC acknowledge Dixie's Tariff Schedules and make them available for public inspection.

After a review of Dixie's Tariff Schedules and DPU's comments, the PSC finds the Tariff Schedules address Dixie's need to provide certain rate schedules to customers in the Flowell service area following Dixie's acquisition of Flowell Electric Association, Inc. and the

Tariff Schedules leave other customers unharmed. Based on that finding and DPU's recommendation, the PSC acknowledges the filing and makes the Tariff Schedules available for public inspection.

Going forward, Dixie should provide the PSC notice of any new or revised tariff schedule at least 30 days before its effective date to avoid any delays or additional administrative processes prior to acknowledgment.
