With the explicit approval and support of counsel for Questar Gas Company and the Utah Division of Public Utilities, the Utah Committee of Consumer Services seeks an extension of the time to file Committee and Division testimony in the above proceedings, otherwise due at close of business tomorrow, September 20, 2005.
