2		I. INTRODUCTION
3	Q.	Please state your name and business address.
4	А.	My name is Craig Val Davidson. My business address is 1109 North 100 West, P.O. Box
5		1670, Beaver, UT.
6	Q.	Who is your employer and what is your position?
7	A.	I am the Administrator for the Beaver Valley Hospital and the Milford Valley Memorial
8		Hospital.
9	Q.	Why are you providing sworn testimony in this proceeding?
10	A.	As you may or may not know, with each passing day it becomes more difficult for rural
11		hospitals to remain financially viable. The reasons for this are two-fold. 1) It is
12		increasingly difficult to receive fair value for services rendered from both Medicare and
13		Medicaid. A large portion of our census at the Beaver Valley Hospital as well as the
14		Milford facility is from Medicare and Medicaid patients. 2) Operating costs continue to
15		escalate. We saw an increase in natural gas rates from 2004 to 2005 of 39% due primarily
16		to commodity cost increases. We are currently on the UTIS4 interruptible rate. The
17		purpose of this proceeding is to eliminate the surcharge associated with the UTIS4 rate and
18		give us instead, the UTI4 rate. For the past three years, the UTIS4 rate has ranged from
19		124% to 183% of the UTI4 rate.
20	Q.	What is the dollar impact of paying the UTIS4 rate compared to the UTI4 rate at the
21		Beaver Valley Hospital?
22	А.	For fiscal year 2005, the difference would have been \$27,093.34. The 2006 difference
23		would have been \$25,876.81. The Milford numbers will be less than these but highly
24		significant nonetheless.
25	Q.	Why are these amounts significant?
26	A.	The current shortage of nurses throughout the country is no less a crisis here. In order to
27		keep our hospital staffed, we must offer competitive rates to nurses. The savings that

could be gleaned from lower utility rates would provide a welcome and significant boost
in our ability to meet our goal of providing high quality healthcare to our patients.

30 Q. Where do your patients come from?

31 Of course most of them come from the community of Beaver. We also receive patients A. 32 from the nearby towns of Minersville, Milford and Parowan. The Beaver Valley Hospital 33 also provides management for the Milford Valley Memorial Hospital that is no less 34 affected by these rates than the Beaver Facility. In addition to the towns and cities nearby, we also are the first responder to accidents that occur along the I-15 corridor in this area. 35 36 We literally treat patients from all over the state as well as the entire country. Though our 37 hospital is located in Beaver we feel we provide important life sustaining service to 38 anyone with a need that happens to be close by.

39 Q. What other reasons exist that have led you to the opinion of supporting the removal 40 of the GSS and EAC rates?

- 41 A. Whether or not our hospital functions in the "black" is largely a function of the level of 42 business activity in the area. Our hospital is best served when industry is moving into our 43 marketing area, creating jobs and making investment. This helps us in many ways. More 44 people are living here that require healthcare services. The tax base is expanded. The 45 quality of life is expanded. I understand from visiting with our economic development 46 people that our utility rates are high enough to discourage companies from locating here 47 when they can go 50 miles away and receive the same service for a fraction of what they 48 would pay here.
