Pursuant to Utah Admin. Code R746-100-3(H) and Utah Code §63-46b-6, Questar Gas
Company requests that the time for interested parties to file responsive comments to the
Commission's Request for Comments be extended to September 4, 2007. In support of its request,
the Company states as follows:

- 1. On June 4, 2007, the Commission issued its request for comments to the Company's Integrated Resource Plan ("IRP) filed May 1, 2007, for plan year May 1, 2007 to April 30, 2008, in accordance with the Modified Guidelines filed with the Commission in Docket No. 97-057-06 on April 17, 1998. In its request, the Commission specifically invited "all interested parties to make comment on the appropriateness of the IRP and to make recommendations on whether the Commission should acknowledge the plan." Further, the Commission invited comment on whether changes should be made to the IRP guidelines approved September 26, 1994, in Docket No. 91-057-09 and if so, the process by which such changes should be made.
- 2. On June 19, 2007, the Utah Division of Public Utilities (Division) requested an extension of the deadline to August 3, 2007, so that it could provide its report in response to the

action request issued to it by the Commission on May 2, 2007 to review the IRP and provide recommendations; and to respond to the Commission's request for comments regarding whether

changes should be made to the IRP guidelines.

3. The Company believes additional time would be helpful to fully develop its

comments and address the issues raised in the Commission's request for comments.

4. Questar Gas has discussed its desire to request an extension with both the Division

and the Committee and both parties have indicated they would not oppose such a request.

5. The Company does not believe an extension of time for interested parties to file

comments will impair this proceeding and will actually afford additional time for interested parties

to complete their review of the IRP and the history that led to the Modified Guidelines and to

organize their comments in a way best suited to facilitate further review and consideration by the

Commission.

WHEREFORE, Questar Gas Company respectfully requests that the Commission enter an

Order extending the deadline to file comments to September 4, 2007.
