**PETITION TO INTERVENE

Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Code § R746-100-7, Nucor Steel, a Division of Nucor Corporation (“Nucor”) hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Nucor states as follows:

1. On December 19, 2007, Questar filed an application with the Commission for an order authorizing an increase in its distribution non-gas rates and charges for natural gas service.
2. Nucor owns and operates a steel mill in Plymouth, Utah, and takes gas transportation service from Questar. Nucor’s full name and primary place of business is:
