REQUEST

The Division of Public Utilities (Division) requests that the Commission delay the schedule in the above mention docket seven (7) business days. Under the current schedule, the Division is to file its report on July 9, 2008. If the Commission grants the Division's request, the Division would file its report on July 18, 2008.

DISCUSSION

In its order dated April 21, 2008, the Commission established the schedule for this docket. Under this schedule the Division is to file its report on July 9, 2008. Other interested parties, including Questar Gas Company (QGC) and the



Committee of Consumer Services (Committee) are to file reply comments or rebuttal testimony on August 15, 2008; surrebuttal testimony or reply comments are scheduled for August 15, 2008. The hearing in this matter is scheduled for August 21-22, with public witness day scheduled on August 21, 2008 from 11:00 a.m. to 1:00 p.m. or later if necessary. The Division is requesting that each of these scheduled dates be delayed by at least 7 business days as follows:

The Division is not proposing a specific date for the hearings at this time, but notes that September 2-3, 2008 would be a delay of eight business days.

The Division and the Committee have exchanged data requests with the Company and the Division is pursuing its analysis of the data and review of related legal and regulatory issues. The delay would allow the Division to follow several additional issues and complete its analysis. The Committee and the Company have indicated that they would not oppose a delay in the Division's filing, as long as there is a corresponding delay in the remainder of the schedule.
