If necessary, the hearing will recess during the Public Witness Hearing noted below and will reconvene at the close of the Public Witness Hearing.

The Parties shall be afforded the opportunity to offer live witness testimony at the hearing and to cross examine any live witnesses offered by other Parties.

Public Witness Hearing. The Public Witness Hearing will occur in two parts.

The Public Witness Hearing will **commence at 11:45 a.m.**Any person wishing to comment during the first portion of the Public Witness Hearing must arrive or join by telephone **no later than 12:30 p.m.** The first portion of the Public Witness Hearing will continue until those members of the public arriving <u>or joining</u> between 11:45 a.m. and 12:30 p.m. have had an opportunity to speak. Upon the conclusion of the comments, the Public Witness Hearing will recess.

The Public Witness Hearing will resume at 4:30 p.m. and will continue until all members of the public wishing to be heard have had an opportunity to speak. Any person wishing to comment during the second portion of the Public Witness Hearing must arrive or join by telephone no later than 5:30 p.m. The second portion of the Public Witness Hearing will continue until those members of the public arriving or joining between 4:30 p.m. and 5:30 p.m. have had an opportunity to speak. Upon the conclusion of the comments, the Public Witness Hearing will recess.

The Commission reserves the right to limit speaking and comment time in order to ensure that those present or participating by telephone may comment.

Members of the public may submit written comments on or before October 22, 2008.

The hearing scheduled above is intended to address all issues investigated by the

Division and examined by other parties and ratepayers as they relate to the individual

customer complaints comprising this consolidated docket, other individual customers, and ratepayers-at-large, such that any Commission decision resulting from the hearing will resolve all such complaints, as well as resolving any questions concerning the accounts of similarly situated under- and over-billed Questar customers who have not filed a complaint and ratepayers-at-large. Should the Commission determine individual hearings are required for the individual complainants or any other ratepayers, such hearings will be scheduled at a later date.

Responses to discovery served on or before September 9November 3, 2008 shall be provided within 14 calendar days of service of the discovery requests. Responses to discovery requests served after September 9November 3, 2008 but on or before September 30, 2008 shall be provided within 10 calendar days of service of the discovery requests. Discovery shall close and no further discovery shall occur after September 30, 2008. Parties may agree to different response and delivery times than those provided in this Scheduling Order.

All oral arguments and hearings will be open to the public, unless portions of them must be closed due to the use of Confidential Information, as provided by the Protective Order previously issued in this docket.

The Commission will provide a telephone conference bridge number so that

ratepayers can listen to the proceedings and offer testimony during the public witness

hearings. Members of the public will also be able to hear the proceedings live, or

subsequently as a podcast, by accessing the Commission's website at www.psc.utah.gov.

It is the intention of the Commission that participants attending by telephone will

be able to listen to, but not to speak during, those portions of the hearings other than the

who wish to participate in a queue, so that each one has an opportunity to speak in the order in which their call was received, and so that all participants are able to hear all the testimony.
