By The Commission:

On March 11, 2013, the Public Service Commission of Utah (“Commission”) issued its order on the Utah Division of Public Utilities (“Division”) proposed plan (“Plan”) for evaluating the Infrastructure Tracker (“Tracker”) pilot program. In that order, the Commission requested the Division to provide a report to be filed by June 1, 2013, addressing the information and issues related to the Tracker since its inception through the 2013 heating season.

On May 28, 2013, the Division filed a request for an extension of the report deadline, noting that Questar Gas Company is preparing additional information to update the impact of the Tracker through year-end 2013. In order to review and analyze the data, the Division requests a postponement of the due date of its report to June 17, 2013.

Based on the foregoing, and for other good cause appearing, the Division’s request for extension to file its report by June 17, 2013, is granted.
