Pursuant to the Scheduling Order issued by the Public Service Commission of Utah (Commission) on September 9, 2010, Questar Gas Company (Questar Gas) submits this Updated List of Issues to be discussed and addressed in this docket. Questar Gas identifies the following as issues to be discussed and addressed:

**1. Cost of Service**

- a. Whether any allocation of costs associated with facilities designed for peak day to interruptible customers is appropriate;
- b. The appropriate allocation factors to be utilized in the cost-of-service (COS) study, any proposed changes to the allocation factor studies themselves, and any changes to the proposed allocation;
- c. What underlying data should be prepared and utilized for the COS study; and

- d. A review of allowances for service line, meter and main costs.

**2. Rate Design**

- a. An evaluation of the administrative charge;
- b. An evaluation of proposed changes to the basic service fee (BSF) including:
  - i. a determination of whether it is appropriate to utilize actual installed capacity instead of a nominal capacity in determining the BSF;
  - ii. an analysis of BSF categories and whether designations are appropriate;
- c. An analysis of FT-1 criteria and whether any changes are appropriate;
- d. An evaluation of whether the cost of service to TS customers should be recovered through a greater TS demand charge based upon marginal (current) costs rather than imbedded costs (such modification would be effected by shifting the recovery from volumetric rates and basic service fees to the demand charge);
- e. An evaluation of a telemetry premium; and
- f. A review of the block rates in the GS class and whether it is appropriate to add third rate block.
