Questar Gas Company (Questar Gas or Company) submits this Motion for Substitution of Section 2.17 of Exhibit 1.8 to its Application for Approval of the 2011 Year Budget for Energy Efficiency Programs and Market Transformation Initiative filed with the Public Service Commission of Utah (Commission) on October 6, 2010.

On October 6, 2010, Questar Gas filed its Application for Approval of the 2011 Year Budget for Energy Efficiency Programs and Market Transformation Initiative in this Docket (Application). The Application sought, among other things, the approval of some program changes to the ThermWise® Weatherization Rebate Program. Most notably, Questar Gas sought approval to allow the payment of rebates within the Weatherization Program only to customers who utilize "Authorized Contractors" to install the weatherization measures. Exhibit 1.8 to the Application contained the

requirements for Authorized Contractors, including a requirement that an Authorized Contractor maintain one of several specifically identified licenses.

Since the Application was filed, Questar Gas sent information to all of its Trade Allies, and held meetings with contractors to inform interested parties of the proposed program changes outlined in the Application, and to obtain input from interested parties relating to the proposed changes. On October 27, 2010, Questar Gas met with interested contractors in St. George. On November 3, 2010, Questar Gas met with interested contractors in Springville. On November 4, 2010, Questar Gas met with interested contractors in Salt Lake City and on November 9, 2010, Questar Gas met with interested contractors in Ogden. Questar Gas has also met with several interested contractors who sought information on an individual basis. During the course of these meetings, many of the interested contractors indicated that some of the licenses identified in Section 2.17 of Exhibit 1.8 were not applicable and that some licenses that should have been included in Section 2.17 of Exhibit 1.8 were not initially included.

In response to the feedback from interested contractors, Questar Gas has revised Section 2.17 of Exhibit 1.8 to indicate that Authorized Contractors must hold at least one of the appropriate and required licenses required by the State of Utah. Questar Gas believes that the broader language attached hereto will allow for the inclusion of contractor licenses the State of Utah's Department of Professional Licensing (DOPL) deem appropriate for the weatherization work, and will allow Questar Gas' program to remain consistent with any changes DOPL may make to its licensing requirements in the future without necessitating a Tariff change. Questar will direct interested parties to a current list of licensing requirements through its website.

Based on the foregoing, Questar Gas respectfully requests that Section 2.17 of Exhibit 1.8 to the Application be removed and that the pages attached hereto as Exhibit 1 be substituted in their place.
