Questar Gas Company (Questar Gas or Company) hereby responds to the issues raised in the Memorandum dated December 6, 2010 (Memorandum), from the Division of Public Utilities (Division) to the Public Service Commission (Commission) submitted in the above-referenced docket. In the Memorandum, the Division recommended partial approval of Questar Gas' Application in this Docket. Specifically, the Division said that it "has reviewed the Application, as filed, and recommends to the PSC approval of most of QGC's 2011 EE Budget. The Division does not recommend approval of the new Direct-Vent Gas Fireplace Measure within the Builder Rebate Program." Memorandum at p.1. Upon receipt of the Memorandum, Questar Gas met with the Division and discussed the issues and concerns. Questar Gas now agrees with the Division's comments, withdraws its request to incorporate the a new Direct-Vent Gas Fireplace Measure within the Builder Rebate

Program, and agrees to the removal of the \$6,000.00 associated with that proposed measure from the proposed budget, as more specifically recommended by the Division.
