In compliance with Commission procedures, the Company hereby files amended Docket No. 10-057-T03 requesting tariff changes. This filing is to comply with multiple Commission orders:

- Commission order dated June 3, 2010, in Docket No. 09-057-16, Application of Questar Gas Company to Increase Distribution Non-Gas Rates and Charges and Make Tariff Modifications.
- Commission order dated July 29, 2010, in Docket No. 10-057-08, Application of Questar Gas Company for a Tariff Change Implementing a Low-Income Assistance Program.
