By The Commission:

On September 10, 2012, Questar Gas Company ("Questar") filed a notice of intent to file an application for approval of the Wexpro II Agreement entered into between Wexpro Company ("Wexpro"), Questar, the Utah Division of Public Utilities ("Division"), and the Wyoming Office of Consumer Advocates ("OCA"). On September 18, 2012, Questar filed the application, along with the direct testimony of Barry L. McKay, General Manager of State Regulatory Affairs for Questar, and James R. Livsey, Vice President and Chief Operating Officer for Wexpro.

As recommended by the Division,¹ the Commission held a duly-noticed scheduling conference on October 3, 2012. At this conference, the parties discussed issues raised in the Utah Office of Consumer Services' ("Office") Request for Pre-Hearing Order and Schedule filed October 2, 2012. The Commission ruled that this proceeding will be a formal adjudicative proceeding. When the parties failed to reach any consensus on a schedule, the Commission continued the conference to October 4, 2012, to facilitate the attendance of a court reporter.

At the October 4, 2012 conference, the parties reached agreement on a schedule for addressing the legal grounds for the Office's opposition to the application, and the schedule was thereafter memorialized in a scheduling order, issued October 16, 2012. On October 22, 2012, counsel for the Office notified the Commission that it was "electing not to file a dispositive motion allowed for by the Commission's October 16, 2012 Scheduling Order."²

On November 7, 2012, the Commission convened a duly-noticed scheduling conference to establish the schedule and process for reviewing the Wexpro II Agreement. In accordance with the discussion at the conference, the parties have agreed to the following schedule for this proceeding:
