FORMAL COMPLAINT OF House of Fuell AGAINST QUESTAR GAS COMPANY.

We request that we meet in person that we might face our accusers in a formal setting as is applicable to any woman or man who has been told that the legal tender that has been remitted is not legal tender. Therefore it is requested that ALL named parties from QUESTAR GAS be present and that NO decision be made with out such face to face meeting to address this formal complaint.

We accept all (who may be reading this), Oaths of Office or the Oath of Office underwhich you fall, your bond and bind you to that Oath.

Forgive us for our not being trained in the art of Color of Law. We being absolute biological property of our Heavenly Father can therefore only be cognizant of His Laws and NOT those manmade laws being intended for those who are U.S. citizens.

We have merely attempted to zero our account with QUESTAR GAS. As is stated in a letter to Kevin Hadlock and carbon copied to PUBLIC SERVICE COMMISSION, Arminda Jurgenson and Linda Kizerian, dated November 26, 2012, (Kevin Haddlock being assigned to disperse copies) copy attached, "Since this is a prepaid account and exempt from levy, you are therefore in commercial dishonor for non-acceptance and payment under section 3-505-510 (3-501-505 typo) of the U.C.C. and are subject to forfeiture and collections under [GAAP] Generally Accepted Accounting Principles. I want these payments posted in the amount of \$195.00 for May 17, Sept 06, \$224.85 and Oct 28 \$354.24 or in the alternative send me the 1096 or 1098 tax returns for this account along with the 1099OID and 1099INT forms, these will show who the payor and recipient of my funds are."

As this is clearly a tax matter, you, Melanie A Reif, Administrative Law Judge, operating as a back-up withholding agent for the IRS, must needs enforce your codes upon those who are subject to those codes. As is confessed in the "MOTION TO DISMISS" brief (?) (MOTION) signed by Arminda I. Jurgenson, QUESTAR GAS has refused to complete and return any of the requested information, including the W-9.

Arminda I. Jurgenson in her MOTION, which looks to us like an affidavit, signed without a notary seal and signature and without the "penalty of perjury" statement. So what is Arminda I. Jurgenson really saying? - Nothing on the record.

Therefore Arminda I. Jurgenson can say in her MOTION (pg 6) "the Oct. Money Order not only neglected to reference any recognized financial institution but also fails to carry any indicia of credibility." And on (pg 7) that "Questar Gas has complied with all statutes, Commission rules, and Tarriff provisions with regard to accepting payment from the Fuell's for natural gas service"

and "required forms of payment and has not received any payment recognized by the Bank as legal tender" and "the Fuell's have presented no claim for which relief may be granted" without any potential harm or loss of BAR license.

It is just common sense! Has QUESTAR GAS returned the original remittance to us? If no, then they have accepted remittance.

Has a WELLS FARGO officer sent in an affidavit signed under penalty of perjury that what WELLS FARGO is purporting, that the May Money Order "RETURN UNPAID NON-TREASURY ITEM."? NO! Why? Because they have in fact received funds from the Treasury and are not willing to sign an affidavit to perjure themselves.

Has a QUESTAR GAS officer sent in an affidavit signed under penalty of perjury that what QUESTAR GAS is purporting, that the May Money Order "RETURN UNPAID NON-TREASURY ITEM."? NO! Why? Because they have in fact received funds from the Treasury or WELLS FARGO and are not willing to sign an affidavit to perjure themselves.

We are requesting relief to the full extent of the law for the time spent (30 hrs so far X \$1,000.00/hr) having to answer QUESTAR GAS inquiries, make phone calls to attempt to resolve QUESTAR GAS frivolous replies as well as going with out heat for an entire weekend.

Relief may be granted to us (House of Fuell) upon proper credidation of the tax assessment, that is, filling out the proper IRS paperwork as has been heretofore requested, that the 1099INT and 1099OID taxes may be credited properly to the issuer of the credit, as well as ALL future remittances. Kevin Hadlock (QUESTAR GAS) being the trustee and fiduciary has failed to act in his fiduciary capacity.


