On January 6, 2014, the Commission issued a Scheduling Order and Notices of Technical Conference and Hearing ("Scheduling Order") in this docket. On April 15, 2014, the Division of Public Utilities ("Division") filed a motion to extend the date for filing non-company direct testimony ("Motion") to allow for ongoing settlement discussions in this docket. Based on the Motion, the Commission issued a First Order Amending Scheduling Order and Notices of Technical Conference and Hearing on April 16, 2014.

On April 28, 2014, Questar Gas Company ("Questar") filed a settlement stipulation ("Stipulation") between Questar and the Division of Public Utilities ("Division"). The Stipulation results in an overall decrease to Questar's revenue requirement and pursuant to the stipulation approved by the Commission in Docket No. 13-057-05, would result in a rate decrease. The Division and Questar propose rates become effective July 1, 2014. The Stipulation indicates Questar and the Division are authorized to represent that the Office of Consumer Services ("Office") does not oppose the Stipulation. No other parties have intervened in this docket.

On May 5, 2014, the Commission issued a Notice of Filing of Stipulation and Comment Period, inviting parties to provide comments on the Stipulation by May 15, 2014, including whether the hearing scheduled in this docket for June 16, 2014, is necessary. Pursuant

to the notice, Questar and the Office filed comments on May 15, 2014, and the Division filed

comments on May 16, 2014, all indicating that a hearing is unnecessary for the Commission to

consider the Stipulation and its associated proposed rate decrease.

Based on the proposed Stipulation and the comments received from Questar, the

Division and the Office and Utah Code Ann. § 54-7-12(2)(d)(ii)¹, the Commission vacates the

remainder of the schedule in this docket, including all testimony due dates and the June 16, 2014,

hearing date. The Commission will issue an order addressing the Stipulation in due course.
