RECOMMEND APPROVAL:

The Division recommends the Commission accept the tariff sheets filed with the Commission on January 28, 2013 under Docket No. 12-057-T01.

ISSUE:

On January 28, 2013, Questar Gas Company (Company) filed an update of their Utah Natural Gas Tariff PSCU 400, §2.03, FS Rate Schedule, §5.01 Conditions of Service; Transportation Service and §5.07, TS Rate Schedule in compliance with a Utah Public Commission (Commission) order issued at the conclusion of the January 25, 2013 hearing in Docket No. 12-057-19. On January 29, 2013, the Commission issued an Action Request to the Division of Public Utilities (Division) to review the tariff filing for compliance to the order. This is the Division response to that request.

DISCUSSION:

This is a re-filing of tariff sheets originally filed with the Commission on December 6, 2012 in Docket No. 12-057-19. The Division responded to that filing in a memo to the Commission dated January 4, 2013 recommending approval of §5.01 Conditions of Service; Transportation Service as filed and approval of revised tariff sheets for §2.03, FS Rate Schedule and §5.07, TS Rate Schedule. The original filing requested an effective date of January 21, 2013 for the proposed changes. At the conclusion of the hearing on these issues, the Commission issued an order approving the proposed changes but modified the effective date to January 25, 2013. On January 28, 2013 the Company submitted finalized tariff sheets to reflect the approved changes.

The Division has reviewed the updated tariff sheets filed in Docket No. 13-057-T01 and finds that the changes to §2.03, §5.01 and §5.07 are in agreement with the January 25, 2013 Commission order with an effective date of January 25, 2013. The Division therefore recommends the Commission accept the tariff sheets and request that the Company issue an advice letter to its Utah Tariff Holders of record informing them of the changes in §2.03, §5.01 and §5.07 of their Utah Natural Gas Tariff PSCU 400.
