Pursuant to Rule 15 of the Utah Rules of Civil Procedure, Utah Code Ann. §54-4-1 *et seq.*, and Utah Administrative Code § R746-100 *et seq.*, Questar Gas Company (Questar Gas or Company), respectfully moves the Utah Public Service Commission (Commission) for leave to amend the proposed changes in its existing PSCU Tariff No. 400 (Tariff) submitted with the Application in this docket, as more specifically set forth herein.

Since the commencement of this Docket, Questar Gas has met with interested parties to this Docket. Based upon those meetings and discussions, Questar Gas proposes to amend the proposed Tariff language as set forth in Exhibits A and B, both attached hereto and incorporated by this reference. Exhibit A is a legislative version of the proposed Tariff language. The blue line represents the Tariff changes originally proposed in the Application in this Docket. The red line reflects the additional changes to that language that the Company proposes today. Exhibit B is a final version of the proposed Tariff language.

The Company is authorized to represent that none of the Parties to this docket oppose the revisions set forth herein.

WHEREFORE, Questar Gas respectfully requests that the Commission, in accordance with its rules and procedures, accept the Amended Proposed Tariff attached as Exhibit A as the proposed Tariff in this docket and approve the changes effective April 1, 2015.
