Pursuant to the request of the Public Service Commission (Commission) during the Public Hearing in the above-referenced docket held on October 30, 2014, Questar Gas Company (Questar Gas or the Company) respectfully submits the following information for the Commission's review. Specifically, during the October 30, 2014 hearing, the Commission requested that the Company identify where, in its 2014 Integrated Resource Plan (2014 IRP), it references the Peak Day Factor shown on QGC Exhibit 1.5 to the Application in this docket.

The Company has attached as QGC Exhibit 1.12 a copy of the spreadsheet utilized to calculate the peak day values set forth in the Company's 2014 IRP. A hard copy of the summary sheet will be filed, along with an electronic copy of the full spreadsheet. For ease of reference, the peak day set forth in the 2014 IRP is detailed in QGC Exhibit 3.9 to the 2014 IRP in Docket No. 14-057-15.

The values shown in the attached QGC Exhibit 1.12 are also used in the peak day demand allocator in the Application in this Docket (*See* QGC Exhibit 1.5, footnote 1). Further review of the attached spreadsheet has shown that the values used for the allocator were for the 2015-2016 heating season instead of the 2014-2015 heating season. That difference does not impact the result because the percentage being allocated to each jurisdiction is the same for both years. The forecasted percentage is based on historical throughput to each state. In the 2014 IRP, 96.99% is allocated to Utah in every year of the forecast. So whether the 2014-2015 heating season or the 2015-2016 heating season is used, the result is that 96.99% of the demand charges will be allocated to Utah, with the rest being allocated to Wyoming.

THEREFORE, Questar Gas respectfully submits this additional information.
