Pursuant to the Utah Public Service Commission's (Commission) bench order in the November 25, 2014 public hearing in the above-referenced docket, Questar Gas Company (Questar Gas or the Company) respectfully submits this supplemental information and the attached updated Tariff sheets. This information and the attachments are provided to update the Infrastructure Rate Adjustment to the distribution non-gas cost portions of the Company's Utah GS, FS, IS, TS, FT-1, MT, and NGV natural gas rate schedules to reflect the use of the most current cost-of service-allocation.

In support of this application, Questar Gas states:

1. <u>Procedural History</u>. On November 3, 2014, Questar Gas filed an application to include an Infrastructure Rate Adjustment to the distribution non-gas portions of its rates. At the hearing for this docket on November 25, 2014, it was determined that the Company used the cost-of-service allocation from the general rate case in Docket 13-057-05, when it should have used the cost-of-service allocation from

its depreciation study submitted in Docket 13-057-19. The depreciation study was originally an issue in the general rate case and was subsequently resolved in a separate docket. It is appropriate to use the cost-of-service allocation in this docket. At the hearing the Company agreed to recalculate the rates using the cost-of-service allocation from Docket 13-057-19 and to submit new Tariff sheets reflecting the cost-of-service allocation set forth in 13-057-19. The Company has updated the attached Tariff sheets to reflect the proper cost-of-service allocation. The Division of Public Utilities (Division) has reviewed the rates for accuracy at the Company's offices. The Company is authorized to represent that the Division does not oppose the approval of these Tariff sheets and the rates set forth therein, on an interim basis, subject to the Division's audit. Therefore, the Company respectfully submits these Tariff sheets to the Commission for approval.

2. <u>Calculation of Updated Rates</u>. Exhibit 1.2U shows the cost-ofservice allocation from Docket number 13-057-19. Exhibit 1.3U shows the effect of the new cost-of-service allocation on the Infrastructure Rate Adjustment rates. The impacted rates are highlighted in yellow on Exhibit 1.3U. As the schedule shows, the GS and FS rate schedules were not impacted by this change. Only the rates in the NGV, IS, FT-1, TS and MT classes were impacted.

3. <u>Change in Typical Customer's Bill.</u> The proposed changes have no effect on GS rates and no effect on the typical customer's bill.

4. <u>Proposed Tariff Sheets.</u> Exhibit 1.5U shows the proposed Tariff rate schedule that reflects the calculation of the Infrastructure Rate Adjustment as explained in paragraphs 1 through 3. Exhibit 1.6U shows the combined tariff sheet that was originally filed for the GS class, with the inclusion of the date, advice number, section revision number and page number. These combined sheets reflect the energy efficiency rates approved by the Commission in Docket 13-057-26.
