On November 3, 2014, Joseph Cook (Mr. Cook) filed a formal complaint against Questar Gas Company (Company), alleging that on or about June 16, 2014, the Company terminated gas service to his residence at 980 Military Drive.

On November 12, 2014, the Division of Public Utilities (Division) filed a recommendation to hold a hearing in this docket. The Division's recommendation is based on a discrepancy between the complainant's name and the name on the account.<sup>2</sup>

The Commission issued a notice of hearing for November 21, 2014.<sup>3</sup> Thereafter, upon the request of the parties, the Commission cancelled the hearing and ordered Mr. Cook to amend his complaint no later than December 5, 2014. That deadline has since passed and no further communication has been received.

Given that the deadline for filing the amended complaint has passed and no further communication has been received, good cause exists to inquire into whether this matter should be dismissed. Thus, the Commission enters the following order:
