Re: Questar Gas, Docket No. 14-057-T04 Proposed Tariff Sheets

RECOMMEND APPROVAL

The Division of Public Utilities (Division) recommends the Public Service Commission of Utah (Commission) accept the tariff sheets as submitted by Questar Gas Company (Company) on June 17, 2014, along with the additional tariff sheet filed June 19, 2014. The June 19, 2014 filing shows the effect of the changes on the CET. The Commission's order in this docket is for rates to become effective July 1, 2014.

ISSUE

On June 6, 2014 the Commission issued its order in Docket No. 13-057-19 approving the Company's new depreciation rates allowing them to become effective July 1, 2014. These new rates effected tariff changes in the following rate schedules; 2.02 GS, 2.03 FS, 2.04 NGV, 4.02 IS, 5.05 FT-1, 5.06 MT, and 5.07 TS. With the change in these rate schedules it necessitates a change in the 2.08 CET tariff also.

On June 17, 2014 the Company filed its proposed tariff pages under this docket, with an additional tariff sheet filed June 19, 2014 for the CET tariff rate. On June 17, 2014 the Commission issued its Action Request to the Division to investigate and review the tariff sheets for compliance with the Commission's order.

This is the Division's response to that Action Request.

DISCUSSION

The Division has reviewed the tariff rates and finds that they are the same as those specified on Table 2:" BASE DNG RATES (\$/decatherm)" of the Commission's June 6, 2014 order. Likewise, the rates in the proposed CET tariff sheet are equivalent to those ordered in "TABLE 3: ALLOWED GS DNG REVENUE PER CUSTOMER PER MONTH" (Stipulation Effective July 1, 2014) as the Commission ordered.

SUMMARY AND CONCLUSION

The Division recommends that the Commission accept the tariff sheets for inclusion in the Questar Gas Company Utah Natural Gas Tariff PSCU 400.
