PETITION TO INTERVENE OF

Pursuant to Utah Code Ann. § 63G-4-207 and Utah Admin. Code § R746-100-7, Rocky Mountain Power (“Rocky Mountain Power”) hereby petitions for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah (“Commission”). In support of this Petition, Rocky Mountain Power states as follows:

1. On March 3, 2016, Questar Gas Company (“Questar”) and Dominion Resources, Inc. (“Dominion”) filed with the Commission a joint notice and application for merger of Questar Corporation and Dominion.
2. Rocky Mountain Power is a certificated provider of electric service to over eight hundred thousand customers in the State of Utah and is regulated by the Commission.
3. Rocky Mountain Power has an interest in the above-captioned matter and may be affected by the outcome as natural gas is a component of electricity generation and directly affects net power costs and customer rates.
4. Rocky Mountain Power’s intervention and participation in this matter will not materially impair the prompt and orderly conduct of this proceeding.


