Dear Mr. McKay:

The Commission reviewed the March 31, 2016 filing by Questar Gas Company (Questar) proposing modifications to Pages 2-12 and 2-14 of its Utah Natural Gas Tariff PSCU 400, Section 2.06 Gas Balancing Account Adjustment Provision (Tariff) and the updated (replacement) proposed changes to the same pages in the Tariff filed by the Division of Public Utilities on April 27, 2016. The proposed changes to the Tariff, filed pursuant to the Commission's November 9, 2015 Order in Docket No. 14-057-31 (Order) identifies how transportation customers' imbalance charges collected by Questar will be accounted for in calculating the monthly accrual to Account No. 191.1. The proposed changes also include updates to the Advice and Section Revision numbers of Section 2.06. Questar requests a May 1, 2016 effective date for these changes.

The Commission also reviewed the April 12 and 27, 2016 action request response and updated action request response (Updated Response), respectively, filed by the Division of Public Utilities (Division). In its Updated Response the Division states that on April 27, 2016, Questar contacted the Division with proposed changes to the Tariff to correct errors in the original filing. The Division represents that these changes correctly identify how the supplier non gas revenues collected from transportation customers will be addressed in the Account No. 191.1 to the benefit of sales customers. The Division concludes the revised Tariff sheets comply with the requirements of the Order, and recommends that the Commission approve the updated proposed Tariff sheets as filed.
