Pursuant to R746-100-4, the Division of Public Utilities (“Division”) files this Motion to Suspend Schedule and for Expedited Consideration (“Motion”). By order issued October 25, 2016, the Public Service Commission of Utah (Commission) set November 23, 2016 as the date by which Mr. Michael Moyal “shall file a response to the Division’s Request” and stated further, “Failure to file a response will result in a default order against Mr. Moyal pursuant to Utah Code § 63G-4-209(1)(c).” The scheduling order also established other dates for actions in this docket.

On November 21, 2016, a meeting was held in which the Division and Mr. Moyal participated. As a result of this discussion, the Division and Mr. Moyal have reached a settlement in principle. The Division is authorized to represent that Mr. Moyal supports

this Motion. There are no other parties to this docket. Once the Division and Mr. Moyal have agreed upon a written memorialization of the settlement, it will be filed with the Commission for approval.

Accordingly, the Division seeks to suspend the schedule in this docket, eliminating the need for Mr. Moyal to file a response by November 23, 2016 and for the Division and Mr. Moyal to take other actions in this docket as specified by the October 25, 2016 scheduling order.

Due to the approaching Wednesday, November 23, 2016, deadline for the filing of Mr. Moyal's response, the Division also respectfully requests that the Commission expeditiously consider this Motion.
