TO ALL PARTIES:

Please take notice that Commissioner Thad LeVar has recused himself from adjudicating this docket due to the following circumstances:

1. On the morning of July 11, 2017, Commissioner LeVar called Mr. Christner to respond to his multiple voicemail messages to PSC personnel expressing dissatisfaction with their answers to his procedural questions.
2. During the July 11, 2017 telephone call, Commissioner LeVar explained the process through which the Public Service Commission adjudicates a complaint docket, and Mr. Christner expressed dislike for that process, which he believes is too formal and too legal.
3. Also during the July 11, 2017 telephone call, Commissioner LeVar agreed to recuse himself from this docket due to his having held an executive management position at the Utah Department of Commerce at the time when that department was a plaintiff in adversarial litigation against Mr. Christner.

Given the foregoing, Commissioner LeVar has determined to recuse himself from all further proceedings in this docket.
