US MAGNESIUM, LLC'S UNOPPOSED MOTION TO STRIKE HEARING DATE

US Magnesium, LLC ("US Mag") hereby submits this Motion to strike the hearing currently scheduled for April 19, 2018 at 10:00 a.m. Counsel for US Mag has spoken with counsel for Dominion Energy Utah ("DEU") and for the Division of Public Utilities ("Division") and can represent that neither DEU nor the Division opposes this Motion to strike the hearing. The basis for the requested relief is set forth below.

On March 12, 2018, the Public Service Commission of Utah ("Commission") issued its Order Granting Partial Summary Judgment ("Order") in this docket. As part of the Order, the Commission stated as follows: "We order both parties to provide the PSC at the time of the hearing with copies of their respective detailed phone records showing all calls and text messages made and received on January 6, 2017, the times of each call and text message, and the

duration of each call." Order at 14. Despite its diligent efforts to comply with the Order, US

Mag has recently learned that it cannot obtain certain of the detailed phone and text records

without issuing a subpoena to the relevant wireless carriers. As such, US Mag has issued a

subpoena to the AT&T Global Legal Demand Center seeking the detailed phone and text records

of US Mag witness Roger Swenson on January 6, 2017. US Mag may be required to issue a

similar subpoena to another wireless carrier to receive certain of the remaining records it has

been ordered to produce. US Mag is unlikely to receive a full response to such subpoenas by the

time of the currently-scheduled April 19, 2018 hearing. US Mag, therefore, does not believe that

it will be able to provide the records the Commission has ordered it to provide at the hearing if

the hearing is held on April 19.

As a result, US Mag requests that the Commission strike the current hearing date. US

Mag will continue to work diligently to obtain the documents it has been ordered to produce to

the Commission at the hearing. Once US Mag receives those documents, US Mag will confer

with DEU, the Division, and the Commission on an appropriate date to re-schedule the hearing.
