# NOTICE OF COMMENT PERIOD

#### ISSUED: August 8, 2019

On October 4, 2018, the Public Service Commission (PSC) issued a Report and Order in this docket ("October Order") that, in part, prospectively suspended certain portions of Section 8.08 of Dominion Energy Utah's (DEU) Utah Natural Gas Tariff PSCU 500 ("Tariff") unless or until the PSC revokes or modifies the suspension.<sup>1</sup> Consistent with the October Order, in mid-October 2018 the PSC initiated rulemaking dockets to address, among other things, the use of utility customer lists, utility-related solicitation communications, and monopoly utility branding.<sup>2</sup> The new rule resulting from these dockets, *i.e.*, Utah Administrative Code (UAC) R746-460, Rules Governing Customer Information and Marketing for Large-Scale Electric and Gas Utilities, took effect on August 7, 2019.

Interested parties may submit comments on or before **Thursday**, **August 22**, **2019** on whether the PSC should revoke, or otherwise modify, the suspension of DEU's Tariff Section 8.08.
