One of the members of our Hangar Owners' Association received a message this evening at approximately 5:30 pm indicating that Dominion plans on making a permanent repair at 8:00 a.m. tomorrow to the temporary asphalt patch that was placed when the "leak" was first discovered. Unfortunately, there was no promise that the gas service was going to be reconnected before the temporary patch was repaired.

By way of this email I am informing Dominion that it is not authorized to make repairs to the asphalt unless it is reconnecting the gas service at the same time. This matter is currently pending before the Public Service Commission and these unilateral actions are not proper or welcome.
