On August 1, 2018, the Company filed an Application to make tariff modifications related to the Transportation Service section of Dominion Energy's Utah Natural Gas Tariff No. 500 (TS Tariff), Docket No. 18-057-T04. On October 23, 2018, the Utah Public Service Commission (Commission) issued an Order Approving the Settlement Stipulation, approving substantive modifications to the TS tariff sheets.

On October 1, 2018, prior to the Commission's approval of the changes to the TS Tariff in Docket No. 18-057-T04, the Company filed an Application in this Docket, as well as applications for modifications to the Daily Transportation Imbalance Charge (Docket No. 18-057-13), to amortize the Conservation Enabling Tariff balancing account (Docket No. 18-057-15), to amortize the Energy Efficiency Deferred Account Balance (Docket No. 18-057-16) and the adjustment to the Low Income/Energy Assistance rate (Docket 18-057-17). The proposed tariff sheets submitted with each of these dockets were based upon the then-effective Tariff, and not the updated TS Tariff, approved on October 23, 2018.

On October 25, 2018, the Company submitted, with its reply comments in this Docket, updated Tariff sheets reflecting changes related to some errors in the rate calculation.

The Company has attached as DEU Exhibit A, for the Commission's convenience, updated TS Tariff sheets reflecting 1) the Tariff language approved in Docket No. 18-057-T04, and 2) the corrected rates submitted with the Company's Reply Comments on October 25, 2018. The Company intends to seek the approval of these final, comprehensive TS Tariff sections at the hearing on this matter.

Based upon the foregoing, the Company respectfully requests that the Commission accept the supplemental information attached hereto as part of the record.
