We find this "Order Dismissing Complaint" "without prejudice" troubling. How can the oversight body not at least listen? As the order stated we did pay in full for the installation. At the very same time we were complaining. We felt compelled to pay and sign the contract. How could we not pay when the service provider is a monopoly power and you need their service? This was much of the basis for our complaint. We would have never used their service if there were alternatives.

Just to be clear. Dominion Energy violated their policy to treat everyone "Fair and Equal". We recognize this is a broad policy. We felt like there was compelling evidence to show that. Without a hearing this evidence will never be brought out into the light. If there is a way to appeal the order please let us know prior to us pursuing other avenues?
