MOTION TO MODIFY SCHEDULING ORDER

Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully moves the Utah Public Service Commission (Commission) to modify its Scheduling Order, Notice of Technical Conference, Notice of Hearing, and Order Suspending Tariff (Scheduling Order) to vacate the deadline for surrebuttal testimony and to permit live surrebuttal testimony at the hearing on this matter scheduled for October 16, 2018.

On August 1, 2018, the Company filed the Application in this matter. On August 17, 2018, the Commission issued the Scheduling Order requiring, among other things, that any surrebuttal testimony be filed by October 10, 2018. Since that time the Company, the Utah Association of Energy Users (UAE), the American Natural Gas Council, Inc. (ANGC) and the Utah Division of Public Utilities (Division) have participated in a technical conference and have submitted pre-filed testimony. Dominion Energy also met

with representatives of UAE, ANGC and the Division to discuss possible settlement. The Company believes that the parties will reach a final settlement agreement in advance of the hearing scheduled in this docket. Rather than requiring parties to submit surrebuttal testimony on October 10, 2018, the Company proposes to vacate that deadline and permit live surrebuttal during the hearing, should the parties fail to reach a settlement agreement. Counsel for Dominion Energy has corresponded with counsel for UAE, ANGC and the Division and all have indicated that they agree to the proposed modification of the Scheduling Order.

WHEREFORE, Dominion Energy respectfully moves the Commission for a modification to the Scheduling Order vacating the deadline for surrebuttal testimony and permitting live surrebuttal testimony at the hearing on this matter, should settlement discussions fail.
