
On August 1, 2018, the Company filed the Application in this matter seeking to modify certain portions of its Utah Natural Gas Tariff No. 500 (Tariff). On August 14, 2018, the Commission held a Scheduling Conference in this matter and on August 17, 2018, the Commission issued a Scheduling Order, Notice of Technical Conference, Notice of Hearing and Order Suspending Tariff. On August 29, 2018, the Commission held a technical conference wherein Company representatives provided information and answered questions relating to the proposed Tariff provisions. On August 22, 2018 the UAE filed a Petition to Intervene in this matter, and on August 23, 2018, the ANGC also petitioned to intervene. The Commission subsequently granted intervention to both. On September 12, 2018, the Division, UAE and ANGC all submitted testimony in this matter. On September 26, 2018, the Division, ANGC and the Company submitted rebuttal testimony in this matter. On October 15, 2018, Company filed the Settlement Stipulation

and corresponding exhibits. On October 16, 2018, the Commission addressed the matters at hearing.

After the Hearing on the matter, the Company became aware that Settlement Stipulation Exhibit C contained errors. The Company therefore seeks to clarify that Settlement Stipulation Exhibit B was an accurate and correct representation of the intent of the Parties. For clarity, the Company has attached as DEU Exhibit 1, a clean version of the Tariff which accurately represents the intent of the Parties entering into the Settlement Stipulation. The Company circulated DEU Exhibit 1 to counsel for all parties, who confirmed that it is an accurate representation of the intent of the Parties. DEU Exhibit 1 hereto is substantively the same as DEU Exhibit B to the Settlement Stipulation. The Company apologizes for the confusion and respectfully requests that the Commission accept this clarifying information.
