**ORDER SUSPENDING TARIFF**

On November 1, 2018, Dominion filed proposed revisions to its Utah Natural Gas Tariff No. 500, Section 7.07 (Gas Quality). Dominion initially requested in its application accompanying its tariff revisions that its tariff revisions become effective December 1, 2018. During the scheduling conference, the parties agreed the tariff revisions Dominion proposes in this docket should be suspended pending the outcome of the hearing on the merits. Accordingly, and good cause appearing, the tariff changes Dominion proposes in its application in this docket are suspended and shall not become effective by operation of statute, pending further order from the PSC.
