Questar Gas Company dba Dominion Energy Utah (Dominion Energy or the Company) respectfully moves the Utah Public Service Commission (Commission) to modify its Scheduling Order, Notice of Technical Conference, Notice of Hearing, and Order Suspending Tariff (Scheduling Order) to vacate the deadlines for Comments and Reply Comments, and to permit testimony at the December 20, 2018 hearing supporting a settlement stipulation.

On November 1, 2018, the Company filed the Application in this matter. On November 7, 2018, the Commission issued the Scheduling Order requiring, among other things, that Comments be filed by December 6, 2018 and that Reply Comments be filed by December 13, 2018. Since that time, the Company, the Utah Division of Public Utilities (Division) and the Utah Office of Consumer Services (Office) (collectively the Parties) have participated in a technical conference. The Parties have also engaged in settlement discussions. The Company believes that the Parties will reach a final settlement agreement in advance of the hearing scheduled in this docket. Rather than requiring the Parties to submit Comments and/or Reply Comments, the Company proposes to vacate those deadlines and permit testimony at the hearing supporting a settlement agreement.

The Company further proposes that it should either file the final settlement stipulation by December 13, 2018, or file a Motion seeking a scheduling conference, in order to schedule further proceedings.

Counsel for Dominion Energy has corresponded with counsel for the Office and the Division and both have indicated that they agree to the proposed modification of the Scheduling Order.

WHEREFORE, Dominion Energy respectfully moves the Commission for a modification to the Scheduling Order vacating the deadlines for Comments and Reply Comments, and permitting testimony at the hearing supporting the settlement agreement.
