Pursuant to Utah Code Ann. § 54-4-1 *et seq.* and Utah Admin. Code R746-1-301, Questar Gas Company dba Dominion Energy Utah (“Company” or “Dominion Energy”) respectfully moves the Utah Public Service Commission (“Commission”) to modify the schedule in this matter to allow the Company to resolve unforeseen scheduling conflicts. In support of this Motion, the Company states as follows:

On January 7, 2019, the Company filed its Notice of Intent to File IRP and Request for Scheduling Order and Notice of Technical Conferences (“Notice”). The Notice provided dates for technical conferences. On January 10, 2019, the Commission issued a Notice of 2019 Pre- and Post- IRP Filing Technical Conferences (“Scheduling Order”) noticing technical conferences on the requested dates.

Since that time, the Company has learned that some of its representatives are not available on the specified dates. Due to unforeseen circumstances, the March 20, 2019, meeting
