Questar Gas Company dba Dominion Energy Utah (Company or Dominion Energy) hereby submits its Updated Cost of Service Model. During the Phase II hearing on the matter, Dominion Energy agreed to work with parties to update the Cost of Service Model previously filed as DEU Exhibit 4.02R. The Company has updated the model and provides it as DEU Exhibit 4.02RU.

The model was built to address questions from the Commission regarding the volumetric rate blocks in the TS class if a gradualism approach is utilized to bring the class to full cost. Accordingly, in the “Steps Proposal” tab of the model, there are three cells that


can be changed to adjust the gradualism rates. These cells are K2, N2, and Q2. The model as filed herein includes the position of the UAE – a 25% increase followed by two increases of 37.5%. Should the Commission decide to use the Company’s proposed gradualism approach, these cells would be changed to 25/25/50 respectively. Any other combination that adds up to 100% can be used and the amounts will flow through to the cost of service and rate design tabs.

All parties have had the opportunity to review and comment upon the model. Counsel for the Utah Division of Public Utilities, the Utah Office of Consumer Services, the Utah Association of Energy Users, US Magnesium, and the Federal Executive Agencies indicated that each party agrees to the submission of the attached model in response to the Commission’s questions. The non-Company parties do not endorse the model as the correct model and each party maintains the positions put forth at the hearing on Phase II of this matter. However, those identified above agree that the model may be submitted in response to the Commission’s inquiry during the hearing. The American Natural Gas Council, Inc. indicates that it does not agree to the submission of the attached model.

Based upon the foregoing, Dominion Energy Utah respectfully submits the attached DEU Exhibit 4.02RU.
