ISSUED: May 14, 2019

This matter is before the Public Service Commission (“PSC”) on the March 12, 2019 complaint (“Complaint”) of Nadra Haffar (“Complainant”) against Dominion Energy Utah (“DEU”). On April 11, 2019, DEU filed a consolidated Response and Motion to Dismiss. On April 11, 2019, the Division of Public Utilities (“DPU”) filed comments recommending the PSC schedule a hearing in this docket because the DPU believes issues of fact exist that require a hearing. On April 26, 2019, Ms. Haffar filed a reply in support of the Complaint and an opposition to DEU’s motion to dismiss.

Having reviewed the Complaint, the DPU’s comments, DEU’s Response and Motion to Dismiss, and Complainant’s Reply, the PSC concludes issues of fact exist that must be resolved at hearing, including but not necessarily limited to the cause and attendant culpability for the alleged crossed meter. Accordingly, DEU’s motion to dismiss is denied.
