	<u>SCHEDULING ORDER, NOTICE OF HEARING, AND DIRECTION TO COMMENT</u>

ISSUED: September 10, 2019

At the consolidated scheduling conference in the above referenced dockets on September 9, 2019, the parties agreed to the schedule set forth below, which the Public Service Commission (PSC) approves and adopts. During the conference, counsel for Dominion Energy Utah (DEU), the Division of Public Utilities (DPU), and the Office of Consumer Services (OCS) took the position that the Utah Supreme Court’s ruling in *Utah Office of Consumer Services and Utah Association of Energy Users v. Public Service Commission et al.*, 2019 UT 26, 445 P.3d 464 (the “Opinion”) does not preclude the PSC from approving interim rates in the pertinent dockets here.

The PSC asks both the DPU and the OCS to explain, in initial comments due September 17, 2019, how they distinguish the interim rates sought here from those the Court held the PSC

lacks the authority to approve in the Opinion. DEU should address this issue in its reply comments.
