Questar Gas Company dba Dominion Energy Utah (“Dominion Energy” or “Company”), hereby moves the Utah Public Service Commission (“Commission”) to modify the Notice of Filing and Comment Period in the above-referenced matter. On June 5, 2019, Alan Kruckenberg Construction (“Complainant”) filed a formal complaint with the Commission. On June 6, 2019, the Commission issued the Notice of Filing and Comment Period requiring Dominion Energy to respond to the Complaint by July 5, 2019. Since that time, Dominion Energy and Complainant (“the Parties”) have engaged in settlement discussions. The Parties believe further settlement discussions are warranted, and therefore request that the Commission modify the Notice of Filing and Comment Period such that they can complete such discussions. To facilitate further discussions, the Parties request the Commission to extend the due date for Dominion Energy’s response to the Formal Complaint to August 2, 2019, and the deadline for submitting reply comments to August 12, 2019.

Dominion Energy has received authorization from Claimant to represent that it agrees with this Motion and, specifically, the proposed extended deadlines discussed above.

Based on the foregoing, Dominion Energy respectfully request that the Commission issue an order extending the briefing schedule as described above.
