ISSUED: November 20, 2020

On November 19, 2020, Dominion Energy Utah (DEU) filed a Motion to Extend the Deadline for Completing the Transponder Replacement Program (“Motion”). DEU states it filed the Motion pursuant to the Public Service Commission’s (PSC) December 10, 2019 Order Approving Settlement Stipulation (“Order”) requiring DEU to complete the transponder replacement program on or before September 30, 2020. According to DEU, in 2015, it discovered some of its transponders were failing at a high rate and that it has been working diligently to replace the failing transponders since the PSC issued its Order. DEU asserts that as of the end of October 2020, only 3,644 transponders remain that need to be replaced. DEU states despite its currently unsuccessful efforts to replace these transponders, it anticipates completion of the transponder replacement program by March 31, 2021 and moves for an order from the PSC extending the deadline to March 31, 2021.

Based on DEU’s representations that the transponder replacement program will be completed by March 31, 2021, the Motion is granted and the deadline is extended.
