1		I. INTRODUCTION
2	Q.	Please state your name and business address.
4	A.	Nick Castleton, 15 N Church St., Eureka, UT 84628.
5	Q.	By whom are you employed and in what capacity?
6	A.	I am employed by Eureka City as Mayor. In a small city like Eureka, I am
7		responsible for the general oversight of all city operations, future planning and public
8		relations. The management and economic strength of Eureka through proper
9		planning is a role I take very seriously. The proposed project to bring natural gas to
10		my community is a project that will ultimately change the future for the city. I have
11		been the key contact from Eureka working with Dominion Energy Utah ("Dominion
12		Energy" or "Company") on this project.
13	Q.	Were your attached exhibits DEU Exhibit 3.0 through 3.03 prepared by you or
14		under your direction?
15	A.	Yes, unless otherwise stated. Where otherwise stated, my exhibits are true and
16		correct copies of the documents they purport to be.
17	Q.	What general areas does your testimony address?
8	Α.	I discuss several matters centered around the benefits of bringing natural gas to
19		Eureka.
20		II. BENEFITS OF NATURAL GAS IN EUREKA
21		A. Growth in Eureka
22	Q.	Is Eureka growing?
23	A.	Yes. There are currently seven homes under construction in Eureka. While this may
24		be a relatively small figure for some communities, for Eureka it demonstrates that the
25		city is growing and represents 2% growth over the existing residential base.

### Q. Is Eureka forecasting growth in the coming years?

27 A. Yes. Eureka is located southwest of Utah Lake just outside of Utah County. Utah 28 County is already expanding to the west and south of Utah Lake, and Eureka 29 anticipates that this growth will begin impacting Eureka in the coming years. There 30 are currently two neighborhoods in the planning phase that will bring as many as 180 31 new homes to the community in the next 2-10 years. Eureka updated its General Plan 32 in 2017 and forecasted growth of about 1% each year for the next 10 years. This can 33 be seen in the introductory section (1.3.6) of the city's General Plan, which I have 34 attached as DEU Exhibit 3.01.

#### Q. Is there potential for industrial or commercial growth in Eureka?

A. Yes. There are two mines in the area, and discussions have been ongoing about those mines opening and beginning operations. Those mines would use natural gas for their mining operations. Additionally, the city has land to the west that may be used for commercial development. If the land is used for commercial development, the city anticipates that prospective commercial business owners will want access to natural gas to heat and operate their businesses.

#### Q. Has the City had interest from commercial developments in the past?

43 A. Yes. I am aware of at least one manufacturer that was interested in operating in 44 Eureka, but could not run a profitable business with access only to propane, which is 45 currently used by many in the city. Eureka would have been a much more attractive 46 option had natural gas been available. Eureka has also been considered as a candidate 47 for economic development projects or as a location for business or manufacturing 48 operations, but our lack of access to natural gas as an energy source has routinely kept 49 the city near the bottom of the list of possible locations for such projects. Access to 50 natural gas in our community will enable Eureka to compete for those economic 51 development opportunities in the future.

52	Q.	Does the Community want to see growth	
----	----	---------------------------------------	--

- A. The vast majority of residents would like to see growth. As part of updating its
  General Plan, the city surveyed residents about residential and commercial growth.
  The results of the survey are included in Appendix B of the General Plan, which I
  have attached as DEU Exhibit 3.02. While some people enjoy Eureka being a small
  town, most would prefer to see growth. Having natural gas in the city will make
  Eureka a more attractive area for people to live and start businesses.
- 59 B. Cost Savings
- Q. Is it anticipated that customers will save money on their energy bills by having access to natural gas?
- A. Yes, absolutely. When Dominion Energy held its open houses in Eureka, it mentioned that a typical customer currently pays about \$635 each year for natural gas. Although each customer is different, this could represent enormous savings for customers in Eureka. I personally use firewood to heat my home, but if I were to use propane, it would cost \$500-\$700 per month in a cold winter month. In the survey responses gathered by Dominion Energy from Eureka customers, cost savings was the largest reason that customers are interested in having access to natural gas.
- 69 Q. Does the propane price fluctuate a lot during the year?
- A. Yes. The cost of propane fluctuates dramatically, as it is subject to supply and demand forces. For example, during the summer, when demand is low, prices are low. But in winter, when demand is high, it is not unusual for prices to double or even triple. For customers that are on a fixed income, these price fluctuations can cause serious budget problems.
- Q. Do these price fluctuations cause customers to sacrifice their comfort to save money?
- 77 A. Yes. Customers in Eureka will frequently try to fill their tank during summer months 78 when prices are low, and then try to make that propane last as long as they can before

refilling at higher prices. This attempt to save on the cost of fuel often leads to customers keeping their homes colder than is ideal. Based on my understanding of Dominion Energy's pricing, its rates are much lower and more stable throughout the year.

#### C. Convenience and Reliability

### Q. Would natural gas be more convenient than existing energy sources in Eureka?

Yes. As I mentioned before, I burn wood to heat my home. This means I have to cut wood for my fires. I also have to be home to monitor a fire if I want the house to *stay* warm. With natural gas, I could set my thermostat and leave for work, knowing that the house wouldn't be freezing when I got home.

Even those who heat their homes with propane would see improved convenience. It is not uncommon for a customer to have to shovel snow to make a path to the propane tank to make sure it has propane. Even when there is a path to the tank, it doesn't mean propane is available immediately. A customer still needs to wait for a propane truck to deliver fuel. On a cold winter day, customers don't want to wait for the warmth that is always available with natural gas.

#### D. Environmental

#### Q. Is Eureka in a non-attainment area, or does it have poor air quality?

A. No. Eureka sits at an elevation of about 6500 ft, so it is usually above any inversions that you see in Utah County. However, since many of our residents are burning wood and coal to heat their homes, Eureka is directly contributing to the air problems in Utah County. Switching these heating sources to natural gas would improve the air quality in Utah County.

#### Q. Is Eureka making commitments to clean air?

103 A. Yes. Eureka has signed a Joint Cooperation Agreement with Dominion Energy to 104 help clean Utah air by working cooperatively to use programs and innovative 107

105 technologies associated with natural gas development, transportation and energy 106 efficiency. A copy of this agreement is attached as DEU Exhibit 3.03.

#### Q. Will extending natural gas service to Eureka help advance these goals?

A. Yes. Having natural gas service in Eureka would make advancing these projects a reality. For example, when the residents of Eureka start taking natural gas service, they will have access to all of Dominion Energy's ThermWise Energy Efficiency programs. Not only can the Eureka residents have access to clean energy resources, they will have access to programs that help them conserve that energy so they are using less, and doing more to improve the environment.

#### Е. Other Options for Natural Gas Service.

#### Q. Has Eureka pursued natural gas service in the past?

A. Yes, but the cost has always been prohibitive. However, I understand that Utah Legislature passed a bill that would allow Dominion Energy to seek approval to extend natural gas service to rural areas, if that extension is approved by the Utah Public Service Commission. Natural gas would be a great benefit to our community, but we can't shoulder the cost ourselves. Dominion Energy's request in this docket is the best, and perhaps the only way for Eureka to receive natural gas service.

#### Q. Do you support a Commission order approving Dominion Energy's request in this docket?

124 A. Eureka cannot finance the extension of Dominion Energy's natural gas 125 distribution system. The only way the residents of Eureka can receive the safety, 126 environmental and cost-savings benefits from natural gas service would be for 127 Dominion Energy to extend its system under the rural expansion legislation. The 128 extension of natural gas service to Eureka will provide immediate benefits to Eureka 129 residents, and will set the stage for future economic growth in the area. 130 I request that the Commission approve Dominion Energy's application to extend natural gas service to Eureka.
