Application of Dominion Energy Utah for Approval of a Natural Gas Clean Air Project and Funding for the Intermountain Industrial Assessment Center

ORDER GRANTING MOTION, AMENDED SCHEDULING ORDER, AND NOTICE OF TELEPHONIC HEARING

ISSUED: July 2, 2020

On May 14, 2020, the Public Service Commission (PSC) issued a Scheduling Order and Notice of Hearing ("Scheduling Order") in this docket. Pursuant to the Scheduling Order, on June 15, 2020, the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) each submitted direct testimony. The Scheduling Order established July 2, 2020 as the deadline for parties to file rebuttal testimony.

On July 1, 2020, Dominion Energy Utah (DEU) filed a Motion to Amend the Scheduling Order to Extend the Rebuttal Testimony Deadline ("Motion"). DEU states it has been discussing settlement with the DPU and the OCS, and anticipates engaging in settlement discussions with the Utah Association of Energy Users (UAE) and Rocky Mountain Power (RMP) in the immediate future. In an effort to afford all parties an opportunity to conclude settlement discussions prior to submitting additional testimony in this docket, DEU requests the PSC extend the filing date for rebuttal testimony to July 8, 2020.

DEU represents it has communicated with DPU, OCS, UAE, and RMP, and that these parties either support or do not oppose the Motion. Good cause appearing, and based on DEU's representation that DPU, OCS, UAE, and RMP support the Motion, the Motion is granted. The schedule is amended as follows:

This hearing will be conducted as an electronic meeting telephonically, with audio only.

While video technology is readily available, the PSC's primary objective is developing an

evidentiary record on which to base its decisions. Video technology provides some advantages

for a hearing, but also presents additional challenges including generally lower quality audio,

higher risk of internet interruptions or other technological complications, and increased potential

for a hearing to be compromised by someone with malicious intent. Many participants in PSC

hearings have years of experience with audio-only telephonic testimony, and the PSC intends to

continue using that technology platform for hearings.
