Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully requests that the Utah Public Service Commission (Commission) vacate the February 15, 2019, hearing date in this docket and schedule a Scheduling Conference.


On January 22, 2019, Company filed its Application for Approval of Modifications to Tariff Section 2.06. On January 29, 2019 the Commission held a Scheduling Conference and subsequently issued a Scheduling Order and Notice of Hearing requiring that comments were due February 8, 2019, Reply Comments were due February 12, 2019 and the hearing would be held on February 15, 2019. On February 8, 2019, the Utah Division of Public Utilities (Division) filed an Action Request Response. On February 12, 2019, the Utah Office of Consumer Services (Office) and Dominion Energy both filed Reply Comments. Since that

time, the Parties have discussed matters raised in the Comments and Reply Comments and have determined that further proceedings may be appropriate. Accordingly, the Company respectfully requests that the Commission vacate the February 15, 2019 hearing date and schedule a Scheduling Conference during which interested parties may seek a schedule for further proceedings. The Company represents that it has communicated with representatives of both the Division and the Office, and both support this Motion.


