DISCOVERY

NOTICE OF ELECTRONIC CONSOLIDATED HEARING

Pursuant to Utah Code Ann. § 52-4-207, on this December 2, 2020, the chair of the PSC makes this written determination that, due to the COVID-19 pandemic and the continued risks of transmission in Utah, the consolidated hearing scheduled for **Monday, December 21, 2020, beginning at 9:00 a.m.** will be conducted as an electronic meeting without an anchor location. An anchor location would provide a substantial risk to the health and safety of those who may be present at the anchor location.
