- B. Mr. Parsons Information Requests:
 - 1. Please provide additional photographs of your home, not your neighbors' homes. The photographs provided by DEU create an inference supporting DEU's contention that your preferred location is inaccessible during heavy winter conditions. Please provide sufficient photos to show a safe walking path, assuming heavy winter conditions. The PSC would like to see that Mr. Parsons' proposed meter location is just as safe as that of DEU's preferred location. Pictures comparing the two locations would be helpful.
